It is brought to the notice of all concerned that "Amkapai Limestone mine" has proposed Limestone Mine over an area of 3.40 Ha located at Amkapai, Elaka Nongtalang, West Jaintia Hills, Meghalaya. The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority as required under the E.I.A.
