PUBLIC NOTICE

It is brought to the notice of all concerned that "**Amsyndui Limestone mine**" has proposed Limestone Mine over an area of **4.30 Ha** located at Amsyndui, Nongtalang, West Jaintia Hills District, Meghalaya. The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14th Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1st December 2009.

In pursuance to the above Notification, the Member Secretary of the Meghalaya State Pollution Control Board vide letter No. MPCB/TB-360/ AMSYNDUI /WJHD/2024-25/3 Dtd. Shillong the 13th May, 2025 has fixed the date of the **PUBLIC HEARING** to be held at the project site, **Amsyndui**, Nongtalang, West Jaintia Hills District, Meghalaya on the **19th June, 2025 from 11:00 AM** onward to record the views, suggestions, objections, etc. put forward by the concerned local affected persons.
