It is brought to the notice of all concerned that **Lynti Dkhar Limestone Mine of Smt. Idalis Ryngnga** has proposed Limestone Mine over an area of 1.36 Ha. at Ri- U- Siar, Sohbar Sirdarship, East Khasi Hills District, Meghalaya. The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14th Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1st December 2009.

In pursuance to the above Notification, the Member Secretary of the Meghalaya State Pollution Control Board vide letter No. MSPCB/TB-360/2025/LYNTI DKHAR IDALIS/EKHD/2025-2026/4 Dated: Shillong, the 13th May, 2025, has fixed the date of the **PUBLIC HEARING** to be held at the project site, Ri- U- Siar, Sohbar Sirdarship, East Khasi Hills District, Meghalaya on the **20th June, 2025 at 11:00 AM** to record the views, suggestions, objections, etc. put forward by the concerned local affected persons.
