PUBLIC NOTICE

It is brought to the notice of all concerned that **ROCHONPARA STONE MINE** of Smti Marsilla Ch Sangma has proposed a Boulder Stone Mine over an area of **1.10 Ha** falling under cluster with total area of **12.93 Ha** at **Rochonpara, P.O Dhyana, West Garo Hills District**, Meghalaya. The Proponent has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14th Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1st December 2009.

In pursuance to the above Notification, the Member Secretary of the Meghalaya State Pollution Control Board vide letter MSPCB/TB/360/2025/Rochonpara Stone Mine/WGHD/2025-26/2 Dated: Shillong, the 4th April, 2025, has fixed the date of the **PUBLIC HEARING** to be held at the project site, **Rochonpara, P.O Dhanua, West Garo Hills District, Meghalaya** on the **13th May, 2025 at 11:00 AM** to record the views, suggestions, objections, etc. put forward by the concerned local affected persons.
