PUBLIC NOTICE

It is brought to the notice of all concerned that **Shri. Khrikshon Lyngkhoi** has proposed Boulder Stone Mine over an area of 4.23 Ha. at Syllai Madan, Laitkynsew, Laitlyngkot, Khyrim Syiemship East Khasi Hills District, Meghalaya. The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14th Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1st December 2009.

In pursuance to the above Notification, the Member Secretary of the Meghalaya State Pollution Control Board vide letter No. MSPCB/TB-360/2025/KL/EKHD/2025-2026/4, Dated: Shillong, the 15th April, 2025, has fixed the date of the **PUBLIC HEARING** to be held at the project site, Syllai Madan, Laitkynsew, Laitlyngkot, Khyrim Syiemship East Khasi Hills District, Meghalaya on the **23rd May, 2025 at 11:00 AM** to record the views, suggestions, objections, etc. put forward by the concerned local affected persons.
