

**PUBLIC NOTICE**

It is brought to the notice of all concerned that **M/s DRON DOHLING** has proposed to set up a Limestone Mine over an area of 1.40 Ha. at Ri Laingut, Tyngwai Area, Sohbar Sirdarship, East Khasi Hills District, Meghalaya. The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority in pursuance to **MoEF&CC O.M. No. L-11011/175/2018-IA-II(M) dated 12<sup>th</sup> December, 2018**.

In pursuance to the provisions of Para 7(i) III .I.A. of Notification, 2006 (S.O. 1533 (E) dated 14<sup>th</sup> Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1<sup>st</sup> December 2009, the Deputy Commissioner, East Khasi Hills District, Shillong has vide letter No. EKJ.20/9/2021/4/165 Dated 10<sup>th</sup> November 2021 fixed the date of the **PUBLIC HEARING** to be held at Sohbar, Sohbar Sirdarship, East Khasi Hills District on the **17<sup>th</sup> December 2021 at 1.00 PM** to record the views, suggestions, objections, etc. put forward by the concerned local affected persons.
