## PUBLIC NOTICE

It is brought to the notice of all concerned that **M/S GREEN VALLIEY INDUSTRIES LTD.** has proposed Shale Mine over an area of 4.77Ha. located at Brichyrnot Village, Elaka Narpuh, East Jaintia Hills District, Meghalaya. The Company has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14<sup>th</sup> Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1<sup>st</sup> December 2009.
