

## **PUBLIC NOTICE**

It is brought to the notice of all concerned that M/s Kermiki Dkhar Limestone Quarry has proposed to set up a Limestone Mine over an area of 4.58 Ha at Wahlathma, Lumshnong, East Jaintia Hills District, Meghalaya. The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority in pursuance to MoEF&CC O.M. No. L-11011/175/2018-IA-II(M) dated 12<sup>th</sup> December, 2018.

In pursuance to the provisions of Para 7(i) III .I.A. of Notification, 2006 (S.O. 1533 (E) dated 14<sup>th</sup> Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1<sup>st</sup> December 2009, the Deputy Commissioner, East Jaintia Hills District, Khliehriat has vide letter No. EJHD/Rev-275/2020/13, dated Khliehriat the 17 February, 2022 fixed the date of the **PUBLIC HEARING** to be held at Lumshnong Village, East Jaintia Hills District, Meghalaya on the **25<sup>th</sup> March 2022 at 12:00 PM** to record the views, suggestions, objections, etc. put forward by the concerned local affected persons.
