It is brought to the notice of all concerned that M/s MEGHALAYA CEMENTS LTD. has proposed expansion of its Cement Clinkerisation Plant from 2600 TPA (0.858 Million MTPA) to 4500 TPD (1.485 Million TPD with 10 MW CPP and 9.5 MW WHRS at Village Thangskai, East Jaintia Hills District, Meghalaya. The Company has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14th Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1st December 2009.
