It is brought to the notice of all concerned that **M/S MUIONG LIMESTONE MINE OF SHRI REMIWELL SOMAN NATEP** has proposed to set up a Limestone Mine over an area of 1.00 Ha. at Muiong, Shella, East Khasi Hills District, Meghalaya. The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority in pursuance to **MoEF&CC O.M. No. L-11011/175/2018-IA-II(M) dated 12<sup>th</sup> December, 2018**.
