It is brought to the notice of all concerned that M/S PRECIOUSLY BAREH LIMESTONE MINE has proposed to set up a Limestone Mine over an area of 1.56 Ha. at Korpet, Nongtalang, West Jaintia Hills District, Meghalaya. The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority in pursuance to MoEF&CC O.M. No. L-11011/175/2018-IA-II(M) dated 12<sup>th</sup> December, 2018.
