It is brought to the notice of all concerned that **M/S PRIIO BUAM** has proposed to set up a Limestone Mine over an area of **4 Ha.** at **Amkhroh Amshalai, Lad Amtapoh, West Jaintia Hills District, Meghalaya.** The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority in pursuance to **MoEF&CC O.M. No. L-11011/175/2018-IA-II(M) dated 12<sup>th</sup> December, 2018.**

In pursuance to the provisions of Para 7(i) III .I.A. of Notification, 2006 (S.O. 1533 (E) dated 14<sup>th</sup> Sept. 2006) and amendment E.I.A.
