It is brought to the notice of all concerned that **M/S ROYAL A SANGMA** has proposed to set up a Limestone Mine over an area of 1.00 Ha. at Bagli, South West Khasi Hills District, Meghalaya. No. L-11011/175/2018-IA-II(M) dated 12th December, 2018**.
