**PUBLIC NOTICE**

It is brought to the notice of all concerned that **SHRI LAMSHWA KYNDOH AND SHRI TENSON DKHAR** have proposed to set up Limestone Mines over an area of 2.97 Ha. and 1.17 Ha respectively which forms a cluster at Lumshnong Village, East Jaintia Hills District, Meghalaya. The applicants have applied for prior Environmental Clearance from the State Environment Impact Assessment Authority in pursuance to **MoEF&CC O.M. No. L-11011/175/2018-IA-II(M) dated 12<sup>th</sup> December, 2018.**

In pursuance to the provisions of Para 7(i) III .I.A. of Notification, 2006 (S.O. 1533 (E) dated 14<sup>th</sup> Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1<sup>st</sup> December 2009, the Deputy Commissioner, East Jaintia Hills District, Khliehriat has vide letters No. EJHD/Rev-311/2022/9, dated Khliehriat the 28<sup>th</sup> July, 2022 fixed the date of the **PUBLIC HEARING** to be held at Lumshnong Village, East Jaintia Hills District, Meghalaya on the **2<sup>nd</sup> September 2022 at 12:00 PM** to record the views, suggestions, objections, etc. put forward by the concerned local affected persons.
