PUBLIC NOTICE

It is brought to the notice of all concerned that **M/s STAR CEMENT LTD.** has proposed expansion of its existing Cement Plant by installation of New Line-II so as to generate Clinker 3.3 MTPA, Cement-2.0 MTPA and WHRB-15.5 MW taking total generating capacity to 4.09 MTPA Clinker, 2.99 MTPA Cement and 20.17 MW waste heat recovery power plant at Village Lumshnong, East Jaintia Hills District, Meghalaya. The Company has applied for prior Environmental Clearance from the Central Government in the Ministry of Environment & Forests as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14th Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1st December 2009.

In pursuance to the provisions of Para 7(i) III of the above Notification, the Deputy Commissioner, East Jaintia Hills District, Khliehriat has vide letter No. EJHD/REV-301/2021/3 Dtd 21st December 2021 fixed the date of the **PUBLIC HEARING** to be held at **LUMSHONG, EAST JAINTIA HILLS DISTRICT, KHLIEHRIAT** on the **29th January 2022 from 2.00 P.M.
