It is brought to the notice of all concerned that **SHRI CHALLENGE RAJEE AND SMTI MARIA RYNGNGA** has proposed to set up Limestone Mines over an area of 2.00 Ha. at Tyngwai Bah and 0.693 Ha at Sohmluh respectively which forms a cluster at Tyngwai Area, Sohbar Sirdarship, East Khasi Hills District, Meghalaya. The applicants have applied for prior Environmental Clearance from the State Environment Impact Assessment Authority in pursuance to **MoEF&CC O.M. No. L-11011/175/2018-IA-II(M) dated 12<sup>th</sup> December, 2018.**
