It is brought to the notice of all concerned that **SHRI CHALLENGE RAJEE** has proposed to set up a Limestone Mine over an area of 8.7511 Ha. at Tyngwai Area, Tyngwai Bah, Sohbar Sirdarship, East Khasi Hills District, Meghalaya. The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority in pursuance to **MoEF&CC O.M.
