## PUBLIC NOTICE

It is brought to the notice of all concerned that M/s JELIKA KHONGRYMMAI, M/s STEPHAN MAJAW AND M/s SYMPER NONGTRAW has proposed to set up Limestone Mines over an area of 1.64 Ha. at Temsuwai, 1.18 Ha at Pammuriang and 0.58 Ha at Mawlyngdiar respectively which forms a cluster at Elaka Wahlong Sirdarship, East Khasi Hills District, Meghalaya. The applicants have applied for prior Environmental Clearance from the State Environment Impact Assessment Authority in pursuance to MoEF&CC O.M. No. L-11011/175/2018-IA-II(M) dated 12<sup>th</sup> December, 2018.
