It is brought to the notice of all concerned that **M/s ARBIS TANGDHARA** has proposed to set up a Limestone Mine over an area of 18.5825 Ha. at Ri Kaleng, Lynti Dkhar Area, Sohbar Sirdarship, East Khasi Hills District, Meghalaya. The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority in pursuance to **MoEF&CC O.M. No. L-11011/175/2018-IA-II(M) dated 12th December, 2018.**

In pursuance to the provisions of Para 7(i) III .I.A. of Notification, 2006 (S.O. 1533 (E) dated 14th Sept. 2006) and amendment E.I.A.
