

### **PUBLIC NOTICE**

It is brought to the notice of all concerned that **M/s ARJUST NONGTRAW** has proposed to set up a Limestone Mine over an area of 0.7162 Ha. at Khlieh Parmaw, Tyngwai Area, Sohbar Sirdarship, East Khasi Hills District, Meghalaya. The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority in pursuance to **MoEF&CC O.M. No. L-11011/175/2018-IA-II(M) dated 12<sup>th</sup> December, 2018.**

In pursuance to the provisions of Para 7(i) III .I.A. of Notification, 2006 (S.O. 1533 (E) dated 14<sup>th</sup> Sept. 2006) and amendment E.I.A.
