It is brought to the notice of all concerned that **M/s PIRTIMAI LYGDOH SYNREM** has proposed to set up a Limestone Mine over an area of 2.499 Ha. at Ri Laingut, Tyngwai Area, Shnongkawar Sohbar Sirdarship, East Khasi Hills District. The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority in pursuance to **MoEF&CC O.M. No. L-11011/175/2018-IA-II(M) dated 12th December, 2018.**

In pursuance to the provisions of Para 7(i) III .I.A. of Notification, 2006 (S.O. 1533 (E) dated 14th Sept. 2006) and amendment E.I.A.
