It is brought to the notice of all concerned that **M/S SUNSHINE MAKRI** has proposed to set up a Limestone Mine over an area of 0.75 Ha. at Tyngwai Area, Sohbar Sirdarship, East Khasi Hills District, Meghalaya. The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority in pursuance to **MoEF&CC O.M. No. L-11011/175/2018-IA-II(M) dated 12th December, 2018.**

In pursuance to the provisions of Para 7(i) III .I.A. of Notification, 2006 (S.O. 1533 (E) dated 14th Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1st December 2009, the Deputy Commissioner, East Khasi Hills District, Shillong has vide letter No. EKJ.20/31/2021/11/6/197 Dated Shillong, the 15th December, 2021 fixed the date of the **PUBLIC HEARING** to be held at Tyngwai Area, Sohbar Sirdarship, East Khasi Hills District on the **18th January 2022 at 1.00 PM** to record the views, suggestions, objections, etc. put forward by the concerned local affected persons.
