**PUBLIC NOTICE**

It is brought to the notice of all concerned that **M/S DURA BIJA BISIK STONE MINE of Shri Kaldok Ch. Sangma** has proposed to set up a Boulder Mining over an area of 2 Ha at Dura Bija Bisik, Dhanua, West Garo Hills District, Meghalaya. The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority in pursuance to **MoEF&CC O.M. No. L-11011/175/2018-IA-II(M) dated 12<sup>th</sup> December, 2018**.

In pursuance to the provisions of Para 7(i) III .I.A. of Notification, 2006 (S.O. 1533 (E) dated 14<sup>th</sup> Sept. 2006) and amendment E.I.A.
