It is brought to the notice of all concerned that **M/s TAMDOR SING NADON** has proposed to set up a Limestone Mine over an area of 1.18 Ha. at Tyngwai Bah, Sohbar Sirdarship, East Khasi Hills District, Meghalaya. The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority in pursuance to **MoEF&CC O.M. No. L-11011/175/2018-IA-II(M) dated 12th December, 2018.**
