It is brought to the notice of all concerned that **STATE INVESTMENT PROJECT MANAGEMENT AND IMPLEMENTATION UNIT** has proposed to set up a Sanitary Landfill and Processing Facility for Municipal Solid Waste near Umsawli, East Khasi Hills District, Meghalaya. The **STATE INVESTMENT PROJECT MANAGEMENT AND IMPLEMENTATION UNIT** has applied for prior Environmental Clearance from the Central Government in the Ministry of Environment & Forests as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14<sup>th</sup> Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1<sup>st</sup> December 2009.
