PUBLIC NOTICE

It is brought to the notice of all concerned that M/s SHRI KHRIKSHON LYNGKHOI has proposed to set up a Boulder Stone Mine over an area of 4.45 Ha at Umduba, Killing, 9th Mile, Raid Marwet, Ri-Bhoi District, Meghalaya. The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority in pursuance to MoEF&CC O.M. No. L-11011/175/2018-IA-II(M) dated 12th December, 2018.

In pursuance to the provisions of Para 7(i) III I.A. of Notification, 2006 (S.O. 1533 (E) dated 14th Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1st December 2009, the Deputy Commissioner, Ri-Bhoi District has vide letter No.DCRB(LR)24/2021/Rev/300/3438, dated Nongpoh the 19th October, 2021 fixed the date of the **PUBLIC HEARING** to be held at Umduba, Killing, 9th Mile, Raid Marwet, Ri-Bhoi District, Meghalaya on the **26th November 2021 at 11:00 AM** to record the views, suggestions, objections, etc. put forward by the concerned local affected persons.
