PUBLIC NOTICE

It is brought to the notice of all concerned that MEGHALAYA ENERGY CORPORATION LTD. has proposed to set up a (3x80 MW) Umngot Hydroelectric Project near the Village Siangkhnai, East Hills District, Meghalaya. The Corporation has applied for prior Environmental Clearance from the Central Government in the Ministry of Environment & Forests as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14th Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1st December 2009.
